The above trainees are instructed to report to General Manager (Admn), MTNL of the concerned Unit for further duties.

- i. During the period of training, the trainees shall be paid monthly consolidated stipend of Rs.12000/-. 12% of this shall be deducted towards EPF contribution.
- ii. They shall be entitled for 12 days CL, 2 days RH and 10 days Medical Leave (supported by a medical certificate from a RMP) during the period of one year training.
- iii. They shall be entitled for Medical benefits for self only as per MTNL Medical Rules.
- iv. They shall not be entitled for any loans advances during the training period.
- v. Trainees shall be provided with shared accommodation for which they shall be liable to pay "Hostel Fees" in terms of the Company Rules in this regard.

Order for posting within the Unit of the above mentioned Trainee Officers shall be issued separately.

During the period of training as indicated above, if it is found that the information furnished and documents submitted are not genuine or any information suppressed and any adverse remark found in Police Verification Report, it will automatically result in termination of training forthwith and the Offer of Appointment will stand withdrawn & cancelled.
